Through the Eurox dedicated portal and support channels, users can log issues, arrange returns, and access resources efficiently – all while contributing to measurable service performance KPIs.

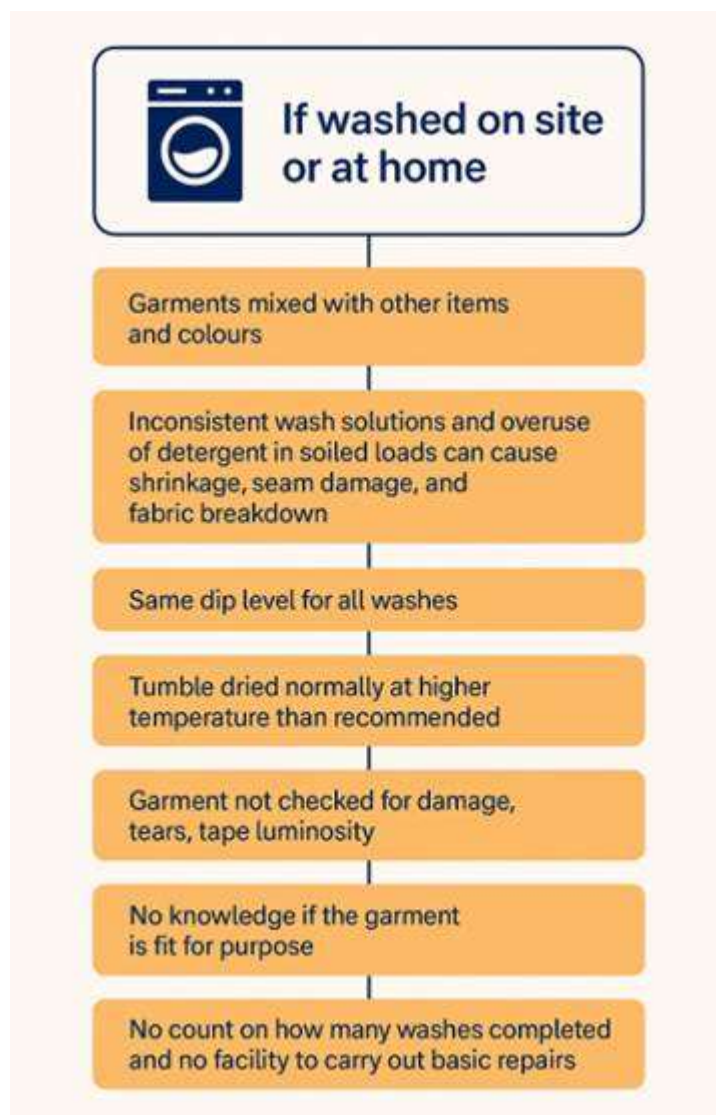
Laundry of Clothing

When manufacturers state an amount of washes that an item should be able to withstand during its lifecycle, this is normally under controlled conditions which would be an industrial laundry process.

The process would cover the following areas:



If the items are washed at site or home, the problems that can occur are:



As long as the wash instructions are followed (by product), you should expect between 25 & up to 50 washes, depending on the fabric, seams, components and tape used. However, without monitoring, this is a very grey area on how the garment is performing.

For optimum expectancy, the rule of thumb is:

PLEASE FOLLOW THE MANUFACTURES WASH INSTRUCTIONS AND THE CARE LABEL INFORMATION.

All garments will have these and also there is normally an insert in the packaging as well as the care label. We are happy to talk about aftercare & maintenance on all PPE by visiting sites and holding “tool box talks”.

Aftercare and storage

CLOTHING: Please follow wash/aftercare instructions provided with each garment or inside on the care instructions label. Do not wash or dry at a higher temperature and always use a low alkaline wash solution. Check for any damage to components, zips, poppers, holes, hi viz tape before wearing. (see attached PPE Inspection criteria guide).

Store by hanging and ensure products are dry. Keep out of direct sunlight.

Top to Toe

Head Protection

Check expiry date on product is still acceptable. Look for cracks on surface or at joints where additional items can be fitted such as earphones/torches. Check size adjuster still functioning and all internal components/chin strap are not worn. Store correctly and not in direct sunlight.

Eye Protection

Make sure fit is still ok and no damage to lens/side arms. Check for scratches and that visibility is not impaired in any way by marks/damage. Store correctly in either hard/soft case and clean regularly with lens wipes and cleaning solutions.

Ear Protection

Check all components and adjustors are functioning correctly and that the fit is comfortable. Make sure there is no physical damage or tear/puncture to the headphones.

Hand Protection

Always ensure correct size selected and check for any tears/rips/holes/abrasive wear.

Foot Protection

Check for holes/tears/scuffing exposure. Ensure all fastenings operate correctly, laces/zips. Check sole for punctures and clean out grips/tread. Clean product regularly with recommended aftercare products.



Selecting PPE

Safety of the wearer

The safety of employees is our number one priority and the necessity to supply the correct PPE based on the risk involved is paramount in the selection process. Fit

Comfort

The end user is most happy and content when they feel comfortable in their clothing. Our design and technical team are always exploring new fabrics, components and styles to offer the best level of wearer comfort.

Ease of Movement

If a garment is too tight, you reduce the wearer's movement capabilities when carrying out manual exercises. This includes stretching, bending, climbing and walking. It is similar if the garment is too big, in both cases, movement becomes restricted and risk of injury can occur.

So, falling in line with fit and comfort, the ability to move naturally is very important to carrying out day to day duties efficiently and effectively.

Style

We recognise how important the style of garments is to represent the corporate image you require. Our design team are proactive in their approach to exploring new features, styles and designs from around the world. It has been recognised that if products are aesthetically pleasing and employees like the style/design, they tend to take better care of it.

Wearing your PPE: How to put on/take off (don/doff) should be self-explanatory for all items, please contact if there are issues when fitting or sizing problems.
